Appendix 1

The criteria for implementation and assessment of the SIW:

At the beginning of the academic period, SIW topics are assigned to each learner. The distribution of topics should be such that each learner covers various forms of SIW implementation. The learner prepares and presents the SIW to the department according to the delivery schedule. The grade is set in accordance with the assessment criteria.

In the context of distance learning, tasks are performed on the topic of SIW within the specified timeframe according to the SIW delivery schedule in the "Task" module. Additionally, the teacher can use on-line discussion of SIW using various information platforms and social networks (group call Wathsapp, Zoom, Webex, Skype, etc.).

1. Essay is a small written work, setting out the knowledge and individual position of the learner on a given question.

Recommendations for essay implementation:

1. Choice of utterance.

- 2. Definition of the statement's problem.
- 3. Formulation of the statement's main idea.
- 4. Determination of your position to the statement.
- 5. Argumentation of one's own opinion.
- 6. Argumentation should be carried out on two levels:

1. Theoretical level - it is based on philosophical knowledge (concepts, terms, contradictions, directions of scientific thought, relationships, as well as the opinions of scientists, thinkers).

2. *Empirical level* - two options are possible here: using examples from social practice and events in society; appeal to personal experience.
